4. The Purchaser may take into account the bidder's overall performance record and execution capability while determining the bidder's suitability for award of the contract.
5. **All bidders who have already submitted their bids are requested to review and, if deemed necessary, resubmit their bids within the stipulated time period. Only the latest bid received before the bid submission deadline shall be considered for evaluation.**
6. The decision of the Purchaser regarding the evaluation of bids and assessment of bidder performance shall be final and binding, subject to the provisions of the tender and applicable procurement guidelines.
